The latest on Economic Nexus

South Dakota vs. Wayfair, Inc. What's that about?

South Dakota asked the U.S. Supreme Court to overturn its long-standing physical presence rule (Quill Corp. v. North Dakota) for determining when a state can make remote sellers collect sales tax.

The Supreme Court ruled in favor of South Dakota on June 21, 2018.

South Dakota is granted authority to impose sales tax obligations on out-ofstate transactions.



ECONOMIC NEXUS

WHAT IS IT?

Economic nexus is a tax collection obligation imposed on sellers based on their level of economic activity within a state.

Unlike physical presence, it is based **entirely** on sales revenue, transaction volume, or both.

Sales tax compliance is now like income tax, all businesses must address where and when they have an obligation




"Because the physical presence of *Quill* is unsound and incorrect, *Quill Corp.* v. *North Dakota*, 504 U.S. 298, and *National Bellas Hess, Inc.* v. *Department of Revenue of Ill.*, 386 U.S. 753, are overturned."


Economic Nexus Expands in 2019

5 states with no state sales tax:

- New Hampshire
- **O**regon
- Montana
- Alaska*
- Delaware

"But what if my company doesn't collect sales tax?"

Economic nexus based on economic activity – increased burden to prove exemptions

Case study: Manufacturer in NY

- 99% of sales are to other OEMs or reseller dealers (no tax)
- Wayfair ruling increased their burden to prove exempt sales
- Previous exemption certificate count:
 <75 on file
- New count needed: 1,175

Case study: National wholesaler

- Sells to resellers who sell to end-users;
 drop shipment is part of their model
- Wayfair grew nexus from just their physical HQ in NY to most U.S. states
- Previous exemption certificate count:500 on file
- New count needed: 5,000+

Even if the \$ threshold isn't met for an economic nexus law, individual transaction count could be.

Exempt sales in states with economic nexus laws


As of June 15, 2019

Delivery into ship-to states, where a supplier did not have nexus

- Pre-Wayfair: exemption certificates not collected
- Post-Wayfair: exempt sales count towards economic thresholds and exemption certificate collection required



^{*}States that include exempt sales in the threshold count but exclude sales for resale




What should you do?

- 1. Don't panic.
- Contact your company's SALT CPA or attorney tax advisor – seek counsel on all nexus related requirements and laws.
 - Don't have one? Avalara has an extensive directory of tax experts and SALT CPAs who could work with your customers
- 3. If no SALT CPA or advisor, leverage Avalara Tax Advisory Services (TAS) work directly with TAS to:
 - Determine where they have nexus
 - Get ongoing monitoring services to see when new nexus is established
 - Register in new jurisdictions
 - Navigate tasks related to establishing new nexus



How does Avalara help its customers track economic

nexus updates?

Frequent economic nexus updates can get confusing but we have economic nexus insights for our users.

- Shows states where a company is approaching (80% shown in yellow) or exceeding (100% shown in orange) an economic threshold, by comparing AvaTax committed sales invoices to the state thresholds
- Points customers to the sales by jurisdiction report and online registration as next steps
- Shows on the AvaTax Update landing page for all accounts that have triggered a notification
